Minutes of the 2023 Annual Meeting

January 26, 2023

The meeting was called to order at 12:08 pm with a quorum of approximately 125 parishioners in attendance. Fr. David Houk opened in prayer. Laura Warner Gilmer was appointed Clerk for the meeting. Fr. Houk recognized the parish staff (Fr. Herb DeWees, Fr. Oliver Butler, Fr. Sam Cripps, Benjamin Kolodziej, Laura Warner Gilmer, Liz Tindall, Kathryn Mills, Katie Jarrett, Elya Beza and the Nursery Staff) and offered gratitude and commendation for their work on behalf of the parish.

Tellers were appointed for the meeting: Jim Waits, Amy Maceo, Nancy Jacobs, and Gwen McAllen.

A motion was made, seconded, and the minutes of the February 20, 2022, meeting were approved as presented in the Annual Parish Meeting booklet.

Fr. Houk introduced the outgoing Vestry members and thanked them for their service: Jane Atchley, Laura Eyre, Jay Patterson, and Lon Williams. The outgoing members were presented with gifts of icons; Jane with "Jesus Walks on Water" in recognition of her gift as a Prayer Warrior; Laura with "Jesus the Good Shepherd" in recognition of her ability to provide uncommon care; Jay with "Christ the Teacher" in recognition of his diligence as a teacher of the Bible and stewardship; and Lon with "Christ the Priest" in honor of his talents in the "care, feeding, and watering of priests." as Senior Warden. Fr. Houk then recognized the continuing Vestry and ex officio members. Nominees to the Vestry election were introduced with a brief description of each: Garry Brown, Doug Collop, Jenee Echard, Jake Jarrell, Sam Leake, and Ann Purcell. Fr. Houk explained the voting procedures and called for nominations from the floor. No new nominations were forthcoming and the motion to close the nominations was made, seconded, and passed. Fr. Houk thanked nominating committee, offered a prayer for discernment, and the balloting commenced.

Head of School Meshea Matthews presented a report for St. John's Episcopal School, sharing that the school had reached its 70th anniversary, had been accredited in 1982, had been written up in D Magazine as one of the "Best Kept Secrets in Dallas", and was currently receiving approximately three applications for each available admissions opening. Ms Mathews went on to recognize the teachers and staff for keeping the school going through COVID-19, a time that was universally difficult for schools. She highlighted the work and contributions of volunteers and alumni, most especially Mickey Ashmore, founder and CEO of Sabah Shoes. Ms Mathews reported that Episcopal identity undergirds all of the school's service objectives and provided an overview of all religious studies, Chapel services, Godly play, and Wednesday Eucharists. She then introduced the school's video presentation, "Connect, Reflect, Envision" and closed with thanks to the parish.

Fr. Houk thanked Ms Mathews and reiterated the invitation to all parishioners to attend school chapel and



Eucharist services during the week. He also recognized and gave thanks for the strong Christian and Episcopal identity of the school.

Fr. Houk recognized and thanked the outgoing Altar Guild Directress Kristin Todora for her service as worship was reestablished after COVID-19. Fr. Houk welcomed Susie Kiraly as the incoming directress and thanked the entire Altar Guild for their service.

Fr. Houk presented the 2022 Parochial Statistics with an explanation of the impact on average Sunday attendance in the calculations of online and in-person worship.

The 2022 Necrology list was read followed by a time of prayer for the departed.

Fr. Houk went on to outline the six Vestry Goals as adopted during the Vestry Retreat. They included: I. Enhance campus security; 2. Add a new Rite 2 service on Sundays; 3. Review and improve parish communications; 4. Renew parish ministries with new volunteer recruitment and ministry training; 5. Develop a new service initiative with high community impact; and 6. Reestablish the importance of in-person worship, discipleship, and service.

The tellers reported the election results. Four Vestry members were elected on the first ballot by majority vote: Garry Brown, Jenee Echard, Sam Leake, and Ann Purcell. Delegates, elected by plurality were announced: Camille Blankenship, Charity Cornelius, Keri Hissim, and Wilson Schoellkopf. Senior Warden Lon Williams introduced Treasure John Bovard to present the 2022 financials. Finance Chair Jamie Jacobs then presented the Vestry-approved 2023 budget. Opportunity was offered for questions.

Mr. Williams returned to the podium and called the parish to appreciate how fortunate St. John's is to have volunteers the caliber of Mr. Bovard and Mr. Jacobs attending to the church's financial health. He went on to recognize Fr. Cripps for his enthusiasm, the work of the Emergency Preparedness Committee, St. John's Episcopal School as "the best Pre-K though 8th in Dallas," Bill Kiraly as an "Outstanding Jr. Warden", and all of the Vestry members for their work and commitment. He recognized Laura Warner Gilmer, Parish Administrator, as "the glue" the holds the parish together. Mr. Williams went on to exhort the gathering to consider Vestry service: Vestry, "Do not wait to be invited or asked – Step Up!" He ended his address by giving thanks to, and expressing thanks for, Fr. Houk.

Fr. Houk introduced Fr. Cripps who expressed his appreciation for the entire parish, staff, ministries and, most especially, Fr. Houk, whom Fr. Cripps described as the hardest working priest he has known.

No new business was introduced to the meeting. A motion was made, seconded, and the meeting was adjourned with a blessing and prayer of thanksgiving at 1:33 p.m.

Elections

VOTING REQUIREMENTS

"Qualified voters at Parish Meetings shall be confirmed persons in good standing of the Parish eighteen (18) years of age or older." (Diocese of Dallas, Canon 13.2) Each member is entitled to one vote on each matter submitted to a vote at a meeting of the members. Voting by proxy is prohibited. "Each confirmed member present who has attained the age of 18 will be entitled to one vote on each matter submitted to a vote at a meeting of the members. Voting by proxy is prohibited." (Bylaws, Section 3.08)

REQUIREMENTS FOR VESTRY CANDIDATES

"To be eligible as a member of the Vestry, one must be at least eighteen (18) years of age, a confirmed communicant in good standing of the Church in that Parish, and a financial contributor of record for at least one (1) year before the election takes place." (Diocese of Dallas, Canon 14.10)

2024 VESTRY NOMINEES

There are eight nominees presented in alphabetical order. You will vote for four.

Vestry Nominee: Doug Collop

Doug has attended St. John's since 2016 and was Confirmed here in 2018. He attends the 11:00 am service.

How have you grown in your relationship with Christ in the past year?

I've grown in the past year in my appreciation of the Father's great love, and the

Son's great faithfulness, resulting in our great and incorruptible hope.



"Making disciples," it seems to me, is what puts aright our understanding that we might possibly practice a Faith, Hope and Love that is pleasing to God.

What gifts and experience would you bring to your Vestry service?

That's a hard one for me to answer, but of course, what I would bring would be my gifts, experience, and strengths, as well as my weaknesses, but I would bring it, and it would be all available; as it might benefit the Vestry.


What gifts and experience would you bring to your Vestry service?

Bjoern and Erin began attending St. John's in 2014 and their son Sam was born and baptized here a year later. They currently attend the 9:15 am service.

How have you grown in your relationship with Christ in the past year?

made it a priority to be more involved with the church. My time is the most valuable thing I can give, and by choosing to spend it serving at church has been very rewarding and strengthened my relationship with Jesus.

What part of the parish's mission statement stands out for you?

"Faith," "love," "worship," and "serve" are words you would expect to see in a Church's mission statement. The part that stands out to me is to "inspire hope." We recite the Prayer of the People and ask the Lord to hear our prayer, but we need to do more than ask. What can each of us do personally to inspire the hopeless and make East Dallas a better place?

What gifts and experience would you bring to your Vestry service?

I have spent more than two decades working for a leading multinational aerospace company. My primary responsibility and experience is managing complex supplier relationships and negotiating contracts with our global supply base. My biggest strength is finding common ground to achieve results by using data driven logic. I think my business experience and background would be beneficial for the Vestry.

Judy has been at St. John's for 32 years. She and Lon attend the 8:00 am Eucharist.

How have you grown in your relationship with Christ in the past year?

My knowledge of scripture grows and I am brought closer to Jesus by being a member of our church's Women's Bible Study. Studying and dis-



cussing the Bible with these faithful ladies is meaningful. I hope to rely more on scripture when dealing with life's challenges.

What part of the parish's mission statement stands out for you?

"Growing in love" stands out to me. I currently volunteer with our Children's Ministry. Watching the children participate in Sunday School and in various activities is fulfilling, fun and, I believe, incredibly important to our Church.

What gifts and experience would you bring to your Vestry service?

I serve on the Children and Youth Ministry Council, the Sandwich ministry, and as a Greeter. Both of our girls attended St. John's Episcopal School from PreK-8th grade. I was an active parent volunteer, school board member for six years and I served on the Head of School search committee. These experiences should positively influence my service.


2023 CONVENTION DELEGATE NOMINEES (CONTINUED)

What gifts and experience would you bring to representing the parish at the Convention?



MUSIC MINISTRY

The music ministries at St. John's continue to strive to glorify God whilst edifying His people through the gift of music. We give thanks for the many blessings of this past year.

The Cantate Deo choir continued to provide music for the II:00 am Sung Eucharist each week, in addition to many seasonal services. They sang Evensongs at Epiphany and Pentecost and started two new traditions this year—a successful "Requiem" concert in November, and an Evensong featuring the "Burning of the Greens." The choir rehearses every Wednesday evening.

I am thankful for those who provide the wonderful receptions at all the concert events, particularly Charity Cornelius, the choir members who bring food items, and Fr. Sholty for his house managing.

I am thankful for the contributions of Katie Jarrett, Assistant Organist and Choirmaster. Katie and I share playing the 8:00 or 9:15 am services each week. She and I have also been leading Sunday School music at 10:00 am. We are thankful to see Sunday School reviving and growing and we hope this will lead to the (re) formation of a children's choir soon. During the summer, we offered Music at Midday concerts monthly on certain Wednesday afternoons, drawing people who do not drive at night. These were played by Katie Jarrett and by me. Through Katie's initiative, we borrowed handbells from Zion Lutheran this summer, forming a handbell group of about 15 people which rehearsed weekly and played in church (in various iterations) several times during the summer.

Post-Easter we will be preparing for our Choral Evensong tour to the UK, singing at the cathedrals of Southwark, Lichfield, and Wells this August. Singers from St. John's and St. Peter's in McKinney will make up the choir.

I am thankful to work amidst the congregation at St. John's, its talented staff, and Fr. Houk, who is so supportive of the music ministry. With God's blessings, we will work toward the flourishing of our music ministries in the coming year.
