COVID 19 POLICIES FROM THE ISRAEL MINISTRY OF HEALTH

As of October 9, 2022, there is no need to present a recovery or vaccination certificate or a negative COVID-19 test result in order to enter Israel.

IMPORTANT: Israel requires tourists to have a health insurance policy with coverage for the treatment of COVID while abroad. Before traveling, you should obtain a letter from your insurance provider that shows you are covered while traveling outside the United States.

Non-Israeli citizens who test positive for COVID-19 during their stay in Israel must comply with the isolation guidance for non-Israelis established by Israel's Ministry of Health. Up to date guidelines are at https://corona.health.gov.il/en/. As of October 15, 2022, the guidelines include:

- You are required to stay in isolation for at least 5 days (the day you test positive is the 1st day of isolation).
- A home antigen test must be taken on the 4th evening of isolation and the 5th evening of isolation.
- If the results of both home tests are negative, and no symptoms have appeared for 48 hours, you can leave the isolation site at the end of day 5.
- If the result of either test is positive, you are required to stay in isolation until the end of day 7, but are not required to take another test.

Any hotel costs required for isolation or travel arrangements resulting from COVID will be borne by the traveler.

TERMS AND CONDITIONS Raji Tours and Travel, Jerusalem

The following terms and conditions apply to all tours booked with and operated by Raji Tours & Travel. All the reservations, cancellations, changes, complaints should be addressed directly with Raji Tours & Travel. Contact information for all operators will be provided along with the confirmation after booking.

Itinerary Variations

Raji Tours is constantly working on improving every itinerary for each group handled. Sometimes conditions and unforeseen circumstances such as imposed security limitations, bad weather conditions and any reason beyond Raji Tours control deem changes on the itinerary necessary, we reserve the right to change and make any necessary variation with the consultation of each tour leader. In these cases, there will be no entitlement to any compensation.

Insurance

Raji Tours doesn't provide insurance for the following: life, health, personal injury, loss or damage to property, loss or theft, trip cancellation, cancelled flights or missed connections.

Tour Price Includes

Hotel reservations based on double supplement, breakfast and dinner, all transportations, transfers and sightseeing as listed in the itinerary, tickets and coupons are included unless otherwise stated in the program. Except for Private tours tickets, coupons and entrance fees are not included. Special needs requirements, such as wheelchairs, walker aid, baby chairs, carriages or any special item require advanced notification. Dietary restrictions, e.g. vegetarian, food sensitivity or any meal restriction will be accommodated with reasonable advanced noticed.

Items not included in the Tour price

Beverages at meals unless specified in the program. single supplement, expenses of a personal nature, COVID tests at the airport, passports, baggage, and insurance of any sort.

Hotels

Accommodations are specified through bookings based on Double, Triple, or Single rooms. A limited number of single rooms accommodations are available at an additional charge.

Meal Plans

Breakfast, dinner, and six lunches (as specified in the brochure) – Dietary Restriction if specified.

Tips

Either included with the tour price, or separately paid by the group tour leader to the hotel staff, guide, bus driver and any other person rendering services to the group.

Payments, Cancellations and Refunds

1. A deposit of \$300 per person should be paid upon confirmation of the group, the total amount should be paid 45 days before the arrival of the group.

2. Refunds are made in full if cancellations are received 45 days prior to arrival of the group.

3. Cancellations made 30-44 days prior to the date of arrival will result in the forfeiting of the deposit. Within 30 days prior to the arrival date additional fees will be assessed depending on the costs incurred by Raji tours & Travel.

4. Cancellations made 30 days prior to the date of arrival will result in the forfeiture of the total payment made.

5. All missed sightseeing trips, transfers, and/or unused hotel accommodations and meals are not refundable.

Responsibility of Tour Operator

1. Raji Tours & Travel its representatives/agents are responsible for the arrangements of all tour transportations, hotel accommodations or any other conveyance for their groups on the condition that they are not liable for any injury, damage, loss, accident, delay or any irregularity which may happen either by reason of defect in any vehicle or through the acts of default of any company or person that engages in conveying the group, or in carrying out the arrangements of the tour or otherwise in connection herewith, or of any hotel proprietor or servant. Such conveying etc., is subject to the laws of the country where the conveyance etc... is provided.

2. Raji Tours can accept no responsibility for losses or additional expenses due to delay or changes in plane or other services, sickness, weather, strikes, war, quarantine, or any other causes.

3. All losses or other expenses will be paid by the travelers. The right is reserved to refuse to accept or retain anyone as a member of any tour at any time or to cancel or alter any tour if circumstances require.

4. Any and/or all transportation companies' representatives herein mentioned shall have or incur no responsibility or liability to any traveler aside from their liabilities as common carriers.

Additional Information

Tours crossing Israeli-Jordanian or Israeli-Egyptian Land borders are subject to government taxes and visa fees payable either in USA dollars or Israeli Shekels ILS at the border. This tax and visa fees are subject to change by the authorities (often on short notices) are out of the Tour Operator control. Once across the border, the Jordanian/Egyptian companies are fully responsible for the group and tours. Travelers who are refused entry at either border crossings by the authorities or decides to withdraw at their own discretion at any stage during the tour, will not be entitled for refunds whatsoever.
